LA 4268-C advised that he has not observed ROSSELLI at the Friar's Club in Beverly Hills, California, for about one week.

The Las Vegas Office advised that as of 9/4/63 ROSSELLI was still registered at the Desert Inn Hotel in Las Vegas, however, he had not been observed in the hotel for two days and that one ALBERT FOLEY, who registered at the hotel on 8/28/63, gave his address as 3669 Old Shell Road, Mobile, Alabama. The Mobile Address would indicate that ALBERT FOLEY is the Jesuit Priest from Spring Hill College, Mobile, Alabama.
